Re: Compliance with Recovery Act Buy American Provisions

Dear Valued Customer:

Recently several of our customers inquired as to whether Heyco's products comply with the Buy American provisions (Section 1605) of the American Recovery and Reinvestment Act of 2009 (the "Recovery Act") which requires that, for Recovery Act-funded projects, all of the iron, steel and manufactured goods incorporated into a public building or public work are manufactured or produced in the United States. After conducting an extensive review of our various product lines, Heyco Products, Inc. hereby certifies that all the products listed below comply with Section 1605. Specifically:

- * Heyco is a U.S.-based designer and manufacturer of wire protection products and electrical/electronic components. Our manufacturing operation is located in Toms River, New Jersey, where we employ highly qualified professionals and use technologically advanced equipment to meet the application needs of our customers.
- * Heyco's Toms River facility uses 25 state-of-the-art, 90-350 ton closed loop injection molding machines, combined with centralized raw material conveying and desiccant drying systems, to produce thousands of high quality standard and custom molded products, such as solar junction boxes, connectors, connector sets, Solar Masthead® cordgrips, SunRunner™ and SunBundler™ solar cable management products; non-metallic liquid tight conduit, tubing, conduit fittings and accessories; a wide range of nylon liquid tight cordgrips – straight-thru, pigtail and right angle – and related locknuts and accessories, strain relief bushings; snap bushings, rubber bumpers and feet; hole plugs in both nylon and LDPE; nylon and PVC "hardware" devices for wire management that meet virtually any wire protection need.
- * Heyco's Toms River facility also uses 10 presses from 22 to 60 tons for high speed production of blades, pins, terminals, female contacts and other electrical components, including a large variety of custom stampings and Turn-2-Lock NEMA cord sets.
- * Heyco provides comprehensive inspection and testing services (including First Article Reports, UL and CSA testing), as well as some in-house, high speed automated assembly of our value-added products.
- * To the extent that the materials utilized by Heyco are not of U.S. origin, the above operations confirm that a substantial transformation has occurred in the United States as required by the implementing regulations.

- * Heyco's pre-assembly equipment and tools are not "brought to the construction site for incorporation into the building" and thus are not covered by the Recovery Act Buy American provisions.
- * Additional products not listed above may also qualify for ARRA funding, contact Heyco Products Inc. for details.
